

## REQUESTS FOR QUOTATIONS (RFQ)

The Govt. of Pakistan (hereinafter called "Borrower") has received financing from the International Development Association (IDA) in the form of a "loan" (hereinafter called "loan") toward the cost of "Punjab Human Capital Investment Project". Punjab Social Protection Authority (PSPA), an implementing agency, intends to apply a portion of the proceeds of this loan to eligible payments under the contract for Procurement of IT Equipment. Accordingly, separate sealed quotations are invited from the local bidders for Lot 1 – Lot 8, which are on the active taxpayers list (Income & Sales Tax) at FBR.

Procurement will be conducted through Requests for Quotations (RFQ) method as specified in *The World Bank's Procurement Regulations for IPF Borrowers July 2016 Revised November 2017 and August 2018* and is open to all eligible bidders as defined in the Procurement Regulations.
