2. Complete details are available in bidding document, which can be purchased from PSPA office on a formal request and cash payment of Rs. 1,000/- (One Thousand Rupees Only). No tender document will be issued through postage or telegram.
3. The bidders are required to give their best and final prices (inclusive of all applicable Taxes & duties etc.), as negotiations are not allowed.
4. Taxes will be deducted as per applicable government rules. Bid Security, NTN and Sales Tax registration certificate and tender fee deposit slip must be provided with the Technical Bid.
5. Bids, which are incomplete, not sealed, not signed and / or not stamped, late or submitted by other than specified mode shall be rejected.
