5. Taxes will be deducted as per applicable government rules. Bid Security, NTN and Sales Tax registration certificate and tender fee deposit slip must be provided with the Technical Bid.-
6. Bids, which are incomplete, not signed and / or not stamped, late or submitted by other than specified mode shall be rejected.
